Part II: Criteria for Disability Discharge

The criteria for disability discharge and borrowing again after disability discharge are outlined in the Federal Student Aid Handbook, Volume 1, Chapter 3, pages 1-82 and 1-83.

Perkins Loans, FFEL and Direct Loans, as well as TEACH Grant service obligations may qualify to be discharged if the borrower/obligation holder becomes totally and permanently disabled. Except for veterans who qualify for a total and permanent disability (TPD) discharge based on a determination by the Department of Veterans Affairs (VA) that they are unemployable due to a service-connected disability, the Department of Education monitors the status of borrowers who have received a TPD discharge for a three-year period.

If a borrower whose prior loan was discharged due to a total and permanent disability wishes to take out another FSA loan or wishes to receive a TEACH grant, they must obtain a physician's certification stating that they have the ability to engage in substantial gainful activity, and they must sign a borrower statement acknowledging that the new FSA loan or the TEACH grant service obligation can't later be discharged for any present impairment unless it deteriorates so that they are again totally and permanently disabled. The student only needs to obtain the physician certification once; the school keeps a copy of it in the student's file. The school must collect a new borrower acknowledgment from the student each time they receive a new loan.

If the borrower requests a new loan or TEACH grant during the post-discharge monitoring period, they must also resume payment on the old loan before receipt of the new loan or TEACH grant. If the loan on which the borrower must resume payment was in default when it was discharged, it remains in default upon reinstatement, and the student must make satisfactory repayment arrangements before receiving the new loan, in addition to meeting the other requirements described.

A borrower who received a TPD discharge based on a determination from the VA and is unemployable due to a service-connected disability is not subject to a monitoring period and is not required to resume payment on the discharged loan as a condition for receiving a new loan. They must still provide the physician's certification and borrower acknowledgment described above.
